## ORDER

The Delhi Medical Council through its Executive Committee examined a complaint of Shri Haridass Padmalayan, Laxmi Electricals, 2120-A, Kanhiya Nagar, Gali No.1, Tri Nagar, Delhi-110035, forwarded by the Directorate of Health Services, Govt. of NCT of Delhi, alleging medical negligence on the part of doctors of Saroj Hospital & Heart Institute, Plot No.2, Institutional Area, Sector-14, Extension, Near Madhuban Chowk, Rohini, New Delhi-110085, in the treatment to the complainant's wife Smt. Laxmi Haridass at Saroj Hospital & Heart Institute.

The Order of the Executive Committee dated 29<sup>th</sup> September, 2015 is reproduced hereinbelow:

"The Executive Committee of the Delhi Medical Council examined a complaint of Shri Haridass Padmalayan, Laxmi Electricals , 2120-A, Kanhiya Nagar, Gali No.1, Tri Nagar, Delhi-110035 (referred hereinafter as the complainant), forwarded by the Directorate of Health Services, Govt. of NCT of Delhi, alleging medical negligence and professional misconduct on the part of doctors of Saroj Hospital & Heart Institute, Plot No.2, Institutional Area, Sector-14, Extension, Near Madhuban Chowk, Rohini, New Delhi-110085 (referred hereinafter as the said Hospital), in the treatment to the complainant's wife Smt. Laxmi Haridass(referred hereinafter as the patient) at Saroj Hospital & Heart Institute.

The Executive Committee perused the complaint, reply thereto of Dr. Kiran Chawla, Dy. G.M. (Medical Operations), Saroj Hospital & Heart Institute, enclosing therewith comments of Dr. Sanjay Sharma,

Consultant Cardiologist, enquiry report dated 27.01.2014 of Saroj Hospital & Heart Institute, copy of medical records of Saroj Hospital & Heart Institute, as provided by the Directorate of Health Services, Govt. of NCT of Delhi and other documents on record.

The grievance of the complainant is that his wife, who had reported to Saroj Hospital & Heart Institute on 14<sup>th</sup> January, 2014 at 10.00 p.m., as she was feeling giddiness, was unnecessarily admitted in CCU of Saroj Hospital & Heart Institute, just to make money, even though her ECG was normal.

The Executive Committee observes that the patient Smt. Laxmi Haridas, a sixty six years old female presented to Saroj Hospital & Heart Institute on 14<sup>th</sup> January, 2014 at 11.00 p.m. with complaint of giddiness, gabrahat. She had history of diabetic mellitus on insulin. On examination, the patient's blood-pressure was 180/80 mmHg. The patient's blood-sugar was 68 mg%. She was diagnosed as a case of diabetic mellitus with hypoglycemia. The patient was investigated, her Trop-T was negative; ECHO reported no RWMA with LVEF 60%, she was managed conservatively and discharged on 16<sup>th</sup> January, 2014.

In light of the observations made herein-above, it is the decision of the Executive Committee that prima-facie no case of medical negligence or professional misconduct is made out on the part of doctors of Saroj Hospital in the treatment administered to the complainant's wife Smt. Laxmi Haridas. The symptoms with which the patient presented with to Saroj Hospital & Heart Institute warranted her admission. The Executive Committee, however, expresses its

disgust at the disparaging and abusive language used in the complaint and censures Shri Haridass Padmalayan for the same.
